**Chairperson of Fundraising/ Ways & Means** is responsible for Fundraising such as Dine Out Nights, Campaign Sales, Soliciting Businesses, Event Sales, ect.

**Chairperson of Transportation & Equipment** is responsible for Transportation for ALL B.O.S.S. events and activities; and maintaining/ updating equipment accordingly

**Chairperson of Campus Events** is responsible for Parent Mandatory Meetings, Visitor Side Concession Stand during Home Football Games, SCSBOA Festival held in March, and Jazz Festival held in April
